## Council Updates

Dear 2nd District Neighbors,

Mayor Gray presented his proposed FY 19 \$370.7 million General Fund Budget on Tuesday, April 10th to the full Council. Since then, the Council has begun the step-by-step process of comprehensively reviewing the proposed budget. The overall review process takes several weeks and enables the Council to conduct comprehensive questioning of the proposed budget before the Council makes a final budget approval in June.

The City's budget comes from taxes, fees, and grants. Fees and property taxes must be used for specific purposes such as waste management, road paving, maintaining city parks and street lights.

There are multiple programs, complex needs, and essential services that we must provide for and adequately fund. Public safety is 55.5% of the proposed General Fund budget that includes new positions in our Fire Department, with 24 to staff a new station in Masterson Station—the largest firefighter force our City has ever had. Also in fire, there is an investment of \$2.7 million in new fire trucks and other vehicles; and \$1.3 million in station maintenance and \$12,000 for the smoke detector program.

Infrastructure improvements included funding for paving, facilities improvements, trail maintenance, new traffic signals, and a Man-O-War traffic study.

Community and economic development funding included funds for the Affordable Housing Fund, homelessness initiatives, jobs fund, workforce development grants, corridor enhancements, convention center improvements and renovations for the city parks projects.

I along with my fellow colleagues continue the work of reviewing the various aspects of the budget in order to create the eventually adopted budget for FY19.

### Learn About Town Branch Commons

- Town Branch Commons is an urban park and trail system that will connect new and existing downtown parks and two city-wide trails, Town Branch Trail and the Legacy Trail.
- The City is overseeing the first phase of construction, including the Town Branch Trail through downtown and the Town Branch Connector along Newtown Pike. When these trails are completed that will be the final link to a 22-mile uninterrupted trail system.
- Step one, beginning spring 2018, is utility construction throughout the corridor including the Midland Avenue sanitary sewer upgrades.
- Join project representatives May 15<sup>th</sup> at the Central Library downtown starting at 5:00pm to learn more about the project plans and upcoming construction.

## YARD WASTE COLLECTION UPDATE

**Due to a driver shortage, yard waste trucks are currently unable to service everyone on their regular collection day. Please leave yard waste carts and brown paper yard waste bags at the curb until they are collected.**

**We are working to correct the issue, but the situation may continue throughout the summer months. Thank you for your patience while we hire and train new drivers.**

- + If your cart has not been serviced, leave it at the curb until it is empty. Carts that are left out for service will not be ticketed by the city.
- + Generally, residents with Monday or Tuesday collection will have missed carts picked up on Wednesday. Residents with Thursday or Friday collection will have missed carts picked up on Saturday.
- + If your yard waste cart was missed, please wait until after your makeup day (Wednesday or Saturday) to report the missed collection.
- + Homeowner associations have been notified about the delayed pickup for yard waste.

## MAY 2018 SERVICE ADJUSTMENT PROPOSALS

### Objectives

- Describe proposed service adjustments that would go into effect in May
- Railroad crossing safety hazard on W 3rd Street affecting Route 2 - Georgetown Road and Route 4 - Newtown Pike
- Improved service to Frederick Douglass High School and Polo Club via Route 10 - Hamburg
- Now serving Pleasant Ridge and Bryant Road via Route 18 - Centre Parkway Connector
- Collect feedback pertaining to May 2018 service adjustments

### Route 2 - Georgetown Adjustments

- Inbound route will utilize 4th Street instead of 3rd Street to avoid railroad crossing.
- Stops currently served on 3rd Street will be moved to Jefferson Street.
- Route 2 end of the line layover location will move from Citation Blvd. to Innovation Drive.

### Route 4 - Newtown Pike Adjustments

- Inbound route will utilize 4th Street instead of 3rd Street to avoid railroad crossing.
- Stops currently served on 3rd Street will be moved to Jefferson Street.

### Route 10 - Hamburg Adjustments

- Frederick Douglas High school will be served on Meeting Street
- Pleasant Ridge Drive and Bryant Road will be moved to Route 18
- Pavilion Way and Vendor Way stops are moved to Sir Barton Way
- Improved Service to Polo Club

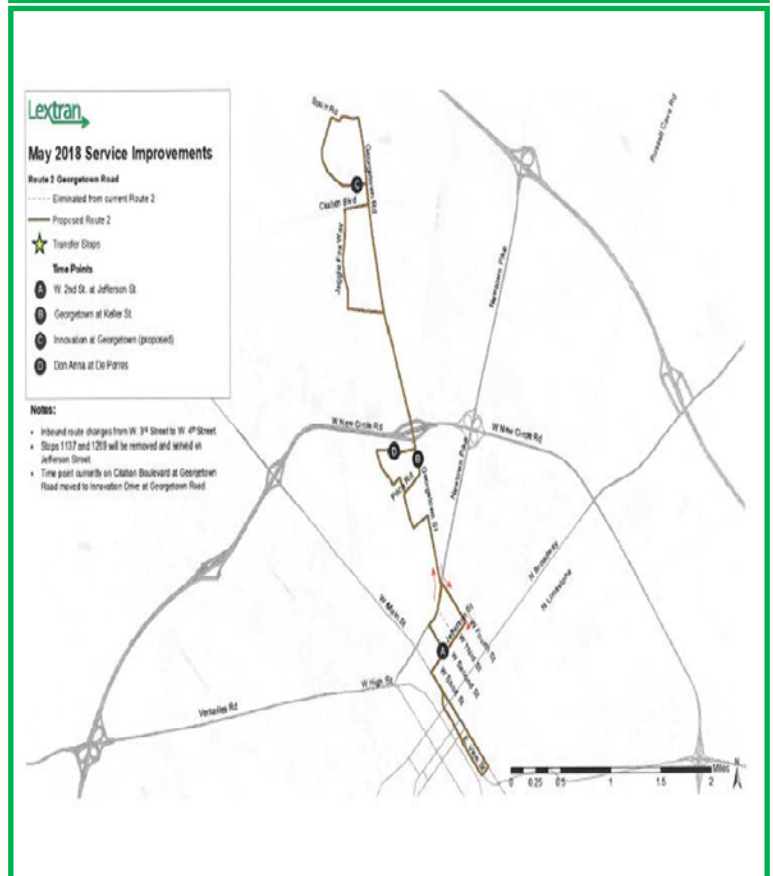
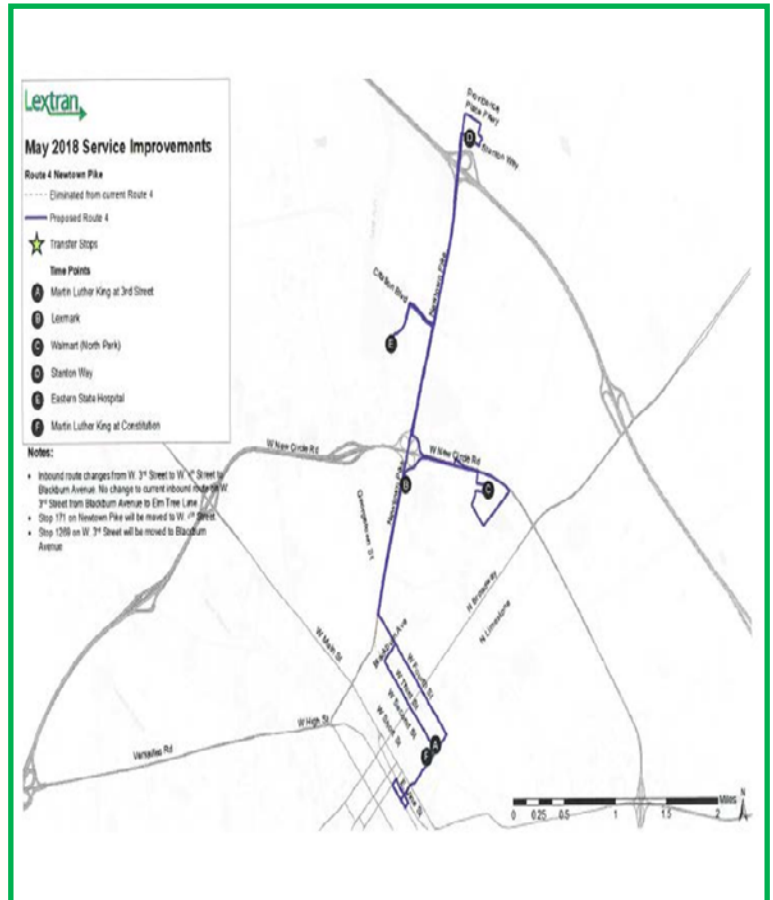
### Route 18 - Centre Parkway Adjustments

## Who are those MetroNet People in my Neighborhood?

Mayor Jim Gray's office released a short video to help Lexington residents learn what to expect from MetroNet's citywide fiber-optic network construction project, now underway in Lexington.

The video, along with frequently asked questions and answers, is available on the city's website, at [www.lexingtonky.gov/gig](http://www.lexingtonky.gov/gig).

"We are very pleased to have MetroNet building its fiber-optic network here in Lexington, giving residents and businesses a new option for gigabit-level internet service, television channels, and telephone service," said Scott Shapiro, who worked on the project for the Mayor's Office along with CIO Aldona Valicenti. "But there will be construction in neighborhoods – a lot of it. This video will give folks a heads up to minimize surprises."



The construction of MetroNet's fiber-optic network, which has already begun in neighborhoods north of Richmond Road, will touch nearly every street in the city over the next three years.

Like Columbia Gas and Kentucky Utilities, MetroNet has a franchise agreement with the city of Lexington that allows the company to access telephone poles and utility easements, which can be in the front or back of people's yards. While MetroNet will not dig trenches, it will conduct some underground boring and dig holes to insert conduit and "planters" that contain equipment.

As this project gets underway, both MetroNet and the city are working to provide information to citizens. At the time construction begins in your neighborhood, you will receive four separate notifications from MetroNet: a letter, a postcard, neighborhood signs, and a smaller sign placed next to mailboxes, Shapiro said. Citizens are encouraged to contact MetroNet to ask questions, learn about construction schedules, or to register any issues that construction crews should know. MetroNet has said that it will respond to inquiries within one business day, and repair any damage that occurs during their work.

MetroNet has put out a special call for people in neighborhoods with underground utilities. Individuals in those neighborhoods who also have irrigation systems, underground dog fences or sump pumps should contact MetroNet so that the company's crews can safely avoid those buried facilities.

"MetroNet is working hard to get through this construction phase and minimize disruption," Shapiro said. "But we are keeping our eyes on the prize. Beginning in some neighborhoods in late summer or early fall, Lexingtonians will have access to some of the fastest internet access in the world."

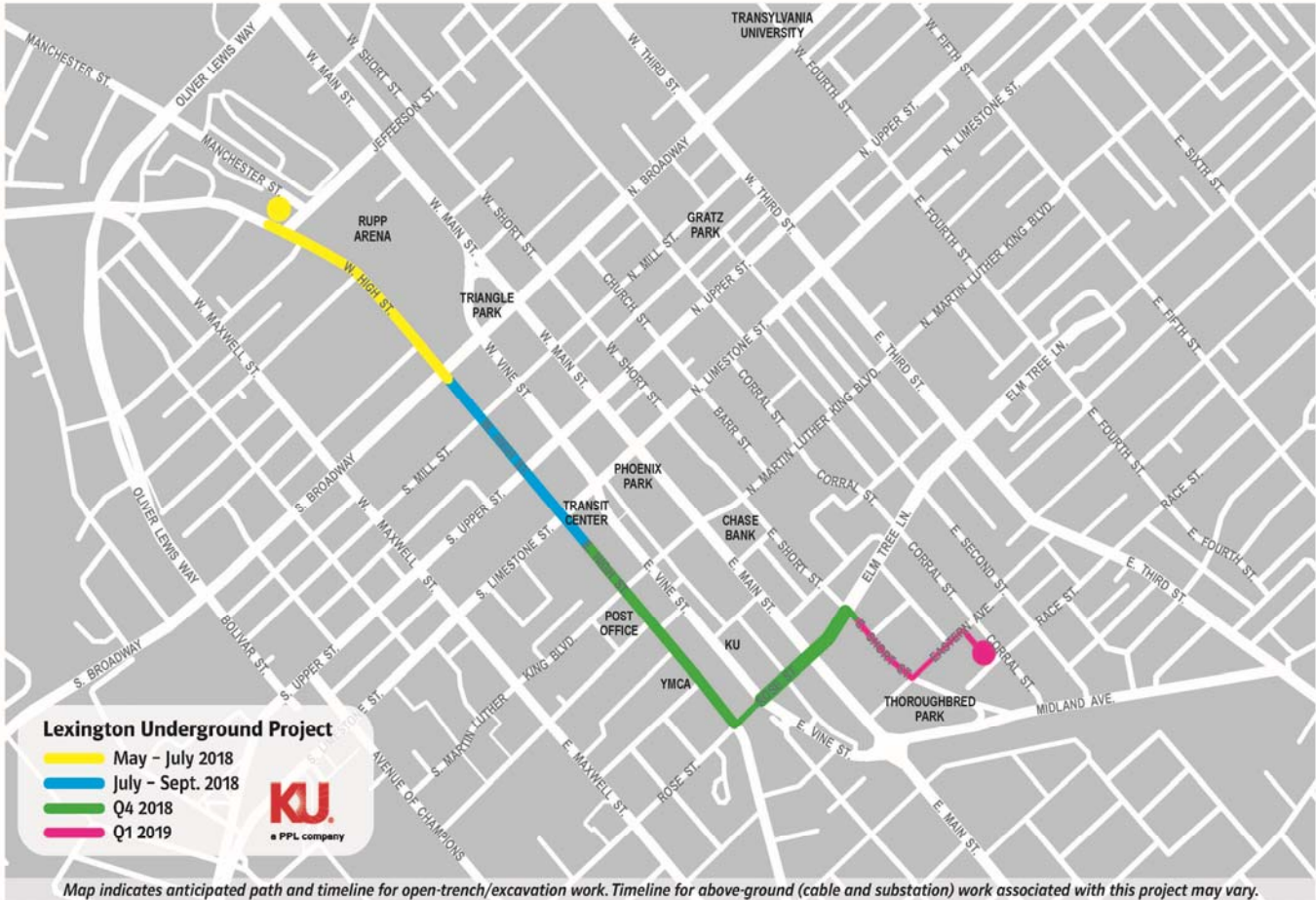

# KU DOWNTOWN LEXINGTON PROJECT ALERT

Within the next couple of weeks, KU will begin a transmission system upgrade project in downtown Lexington. The project will involve the construction and replacement of portions of underground and overhead electric transmission infrastructure across two miles of the downtown area.

When completed, the work is expected to reduce electric service interruptions to customers within the area and enhance electric reliability throughout the system.

## BLUEGRASSS CLASSIC STOCKDOG TRIAL EVENT

### Nation's top handlers to compete at 57<sup>th</sup> annual Bluegrass Classic Stockdog Trial

The 57<sup>th</sup> annual [Bluegrass Classic Stockdog Trial](#) will once again return to Lexington's Masterson Station Park, showcasing the country's best dog handlers and herding dogs. The elite competition will take place May 16 – 20, from dawn to dusk each day.

The five-day event will feature more than 600 dog-handler teams, culminating with a 'best-of-the-best' final competition on Sunday, May 20. More than 500 sheep are transported from Montana to Kentucky for this prestigious event, considered to be the best stockdog event east of the Rocky Mountains.

"The general public first became familiar with stockdog trials after the release of the popular movie 'Babe,' but you can't really appreciate the precise skill and training that goes into a competition like this without seeing it live and in-person," said Marianna Schreeder, president of the Bluegrass Classic Stockdog Trial. "The bond between handlers and their dogs is truly unmatched, and it is a real treat to watch these world-class animals compete at the highest level."

The Bluegrass Classic is free and open to the public for all five days. There will be raffles each day, and food and drinks available for purchase. Spectators are encouraged to bring blankets or lawn chairs for sitting. Attendees may also bring their own dogs, as long as they are leashed.

Some of the top handlers that will be appearing at this year's Bluegrass Classic include Scotsman Tom Wilson, the defending Bluegrass Champion and two-time David Letterman guest; Scotsman Alasdair MacRae, who has been featured in articles by the Wall Street Journal and Smithsonian magazines; and Canadian Scott Glen, the defending National Champion.

On March 2, 2017, the Urban County Council enacted Section 14-106 of the Code of Ordinances to regulate the placement of unsolicited written materials. By definition, unsolicited written materials are written materials delivered to a premises without express permission of the owner, occupant or lessee. Examples may include, but are not limited to, advertising circulars, coupons, pamphlets, newsletters, books or magazines left without permission.

Under the ordinance, the delivery of unsolicited written materials is restricted to the following areas:

- on a porch nearest the front door;
- securely attached to the front door;
- through a mail slot on the front door;
- between the exterior front door (if one exists and is unlocked) and interior front door;
- in a distribution box on or adjacent to the premises;
- or by personal delivery to the owner, occupant, or lessee.

If unsolicited written materials are delivered to any of these areas, no violation of the ordinance has occurred.

**Effective June 1, 2018**, the city of Lexington will begin enforcing the ordinance. If you believe that a violation of the ordinance has occurred *prior* to June 1, you may contact Lexcall at (859) 425-2255 and a warning will be issued to the potential violator. On or after this date, you may file a complaint with the city's Division of Code Enforcement.
